APPLICATION RATES

If pond/lake contains algae, treat with an algaecide first. Two days later, apply Accelerator across the surface at a rate of 10-20 lbs. per surface acre/foot.

Apply using a boat mounted clean seed spreader, whirlybird spreader, or pour slowly into prop wash. (Clean spreader after application of Accelerator) Cover as much of the water surface as possible. Repeat as necessary.

SAFETY PRECAUTIONS

Avoid contact with eyes. Wear chemical goggles. Avoid prolonged contact with skin. Wear chemical resistant gloves. Do not ingest. Avoid breathing dust. Wash thoroughly after handling. Keep container closed when not in use. Avoid contamination with moisture and dirt and store away from direct sunlight. Do not transfer to unlabeled containers.

First Aid:

Inhalation – Move victim to fresh air. Call a physician in case of respiratory problems.

Eye Contact – Immediately flush with running water for at least 15 minutes. Call a physician.

Skin Contact – Remove contaminated clothing and wash skin and clothing with soap and water.

Spills and Leaks – Sweep and store in vented plastic container. Do not return to original container. Dispose of in accordance with local, state, and federal regulations. Flush spill area with water.

Fire – Flood with water.
