

PRODUCT DESCRIPTION

AquaKler is a unique patent-pending granular formulation that drastically improves an aquatic ecosystem, often with just a single application. The granules are specially formulated for the slow release of oxygen in aquatic systems. The oxygen release rate is tailored to the need of the sediment and water being treated. The resulting increase in dissolved oxygen decreases odor, and reduces sludge resulting in greater water clarity.

The AquaKler granules are also designed to enhance the oxidation potential at the sediment-water interface. This patented technology leads to a dramatic long-term control of phosphorus loading; a major factor in the degradation of aquatic environments. This makes AquaKler both an economically and ecologically sound aquatic treatment for the long term restoration of oxygen-deficient water.

APPLICATION RATES

If the pond/lake contains algae, treat with an algacide first. Two days later, apply AquaKler across the surface at a rate of 20-80 lbs per surface acre. Depending on water condition, higher rates can be used initially until organic buildup and/or phosphate level has diminished to a manageable level.

Apply using a boat mounted clean seed spreader, whirlybird spreader, or pour slowly into prop wash. (clean spreader after application of AquaKler) Cover as much of the water surface as possible. Repeat as necessary. Conditions and results will vary by geographic location, phosphate concentration, volume of organic load (manure, etc.) and water temperature.
